## Who We Are

We operate one of the ONLY centralized housing information centers. The Central Jersey Housing Resource Center (CJHRC) assists approximately 1,500 clients annually at **NO CHARGE**.

CJHRC is a HUD certified housing counseling agency that provides clients with information to reach their housing goals. We use our extensive resources to find affordable housing for households, individuals, senior citizens and those with special needs.

CJHRC is the Fair Housing Office for Somerset County. Any resident that has a question or issue relating to the Fair Housing Act, please contact our office for assistance.

### Languages Offered

CJHRC services and information (resources/documents) are provided in English. Clients may request a Spanish-speaking CJHRC counselor, or they can request interpretation and/or translation services. CJHRC will utilize their Translation Service Company with 220 languages available.

## 5 Key Certificate Programs

Certificates may be required as a pre-requisite for various programs to attain housing, grants and other financial goals. Certificates earned are valid for one calendar year from date of issue. These programs provided are free of charge.

### 1. RENTAL INFO & RESOURCES WEBINAR

- For renters and potential renters
- This program will prepare you for all aspects of the rental process, including Federal/State housing programs, assistance programs, credit and budget issues, security deposits, etc.
- Offered twice a year, it includes a 2.5 hour webinar (session criteria must be met to receive a certificate).

### 2. PRE-PURCHASE VIRTUAL WEBINAR

- For individuals and households who want to buy their first home.
- This HUD certified virtual webinar will provide a comprehensive overview of the home buying process. You will hear from local industry professionals about how to become a successful homeowner and relevant topics.
- Offered several times throughout the year
- Includes 2 x 2.75 hour webinars held over 2 evenings (both sessions must be attended to receive a certificate).

### 3. MAKE YOUR MOVE: A GUIDE TO HOMEOWNERSHIP

- For individuals and households who want to buy their first home .
- A combination of individual counseling (60-90 min.) and web-based homebuyer education .
- This program will prepare you for all aspects of the home buying process.
- All modules and tests must be completed within 30 days to receive a certificate.

### 4. FINANCIAL LITERACY VIRTUAL WEBINAR

- For those seeking credit for the first time, have been denied credit, or are just plain confused when it comes to credit.
- Participants who complete the webinar are able to book an appointment with a CJHRC counselor to receive a Tri-Merge soft pull credit report free of charge (\$40 value).
- Offered twice a year, it includes a 2.5 hour webinar (session criteria must be met to receive a certificate)

### 5. MONEY IN MOTION: FINANCIAL LITERACY COUNSELING

- For individuals and households who need financial literacy education who are unable to attend a financial literacy virtual webinar.
- A combination of individual counseling (60-90 min.) and web-based financial literacy education.
- All modules and tests must be completed within 30 days to receive a certificate.
- This service is also offered in Spanish.
